Canada Ontario Housing Benefit (COHB) Program


- Portable housing benefit to assist with rental costs in the private housing market. The benefit is tied to the household and can be used to help pay rent anywhere in Ontario
- Provincial Federal program part of the National Housing Strategy
- Program launched on April 1, 2020
- The COHB program funding ends on March 31, 2029
- Recipients must be removed from the Centralized Waiting List



COHB Year 4 Program Outcomes

- Over **4,000 households** are currently receiving COHB
- Shelter Relief Stream was introduced in Year 3 and became the leading pathway to permanent housing.
 - Over 2,600 shelter residents housed
- Year 4 funding launched in April 1 and was exhausted within two months
- Stopped accepting referrals on May 12, causing significant pressure on shelter system

COHB Year 4 - Additional Allocations

- Senior Management engaged in ongoing intergovernmental advocacy to build on the demonstrated success of the COHB program.
 - On July 19, 2023, City Council approved an additional allocation of \$13.4M to the to the Toronto COHB program, jointly funded by the City and the Province
 - On September 18, 2023, the Province announced an additional \$13.08M in COHB funding
- It is estimated that the additional funding will provide COHB benefits to approximately **2,100** households
 - This should sustain the current rate of take up of approximately **300 new applications/ month** to the end of the funding period (March 31, 2024).



COHB Year 4 - Additional Allocation

The COHB Year 4 Additional Allocation was launched on Aug 22

Outcomes as of Friday, October 6

- Shelter Relief Stream
 - 582 referrals
 - 55% Chronically Homeless
 - 85% Asylum Seekers
- Indigenous Households
 - 27 referrals

COHB Renewals

- All COHB applicants are required to complete an annual renewal form and file their income taxes in order to maintain their benefit
- Over **1,600** former shelter residents had to complete the annual renewal process in 2023
- We met with other municipalities that have prioritized Shelter residents for the COHB benefit, consistent feedback received:
 - COHB worked very well to move clients from the shelter to housing but a very large percentage of the former shelter residents failed to renew their COHB and re-entered the shelter system




COHB Renewal Strategy Collaboration, Housing Stability and Shelter Diversion

Housing Stability Services lead a Cross Divisional Renewal Strategy to support former Shelter residents to maintain their COHB benefit

97% of COHB households in Toronto have successfully completed the Annual Renewal process.

3% have outstanding COHB renewals

Preparing for Next Renewal Period

New COHB recipients

- Request a Follow up worker for clients who may have difficulty completing income taxes and completing renewal
- Ensure clients understand the COHB program and the annual renewal requirements
- Review the Q and A for households referred to COHB and provide them with a copy
- If possible **retain contact details** of clients referred into COHB so you can support the Renewal Strategy next year
