

Federal Housing Advocate Submissions

The Office of the Federal Housing Advocate is currently accepting submissions to two critical reviews:

- Homelessness Encampments
- Financialization of Housing

The Advocate's review on encampments

The Federal Housing Advocate has launched a formal review of encampments in Canada to address this serious human rights crisis happening in cities across the country.

The Advocate's review will focus on systemic solutions to address the factors that lead to encampments, as well as the daily struggles of the people who live there. At the conclusion of the review, the Advocate will submit her findings and recommendations to the federal Minister responsible for housing, and also make recommendations to other levels of government and other stakeholders.

The review will be guided by the principles of a human rights-based approach. The Advocate will collect testimony from people living in encampments, and also engage with civil society organizations that serve them, as well as experts in human rights and housing. The Advocate will also engage with duty-bearers from federal, provincial or territorial, and municipal governments.

TAEH Anti-Oppression & Equity Working Group

G – TAEH is grounded in Equity/AntiOppression
Framework

G.1 – Adopt an Anti-Oppression (AOP) Framework to hold TAEH accountable G.1.1 – Convene the Equity and Anti-Oppression Working Group (working title)

G.1.2 – Develop the AOP Framework, including:

- Board policies/positions
- Supporting by-laws if appropriate
- Organizational, HR etc. policies

G.1.3 – Integrate the AOP Framework into all parts of TAEH

- Support continuous learning opportunities
- Identify processes to ensure an equity lens is applied to all TAEH position papers, working group outputs, etc.
- Engage Equity Working Group in processes to identify TAEH strategic priorities on a regular basis

The Advocate's research on Financialization

The Office of the Federal Housing Advocate led a research project that brought together five researchers to examine the growing role of private equity and investment firms in the residential real estate market and long-term care in Canada.

The research demonstrates that the financialization of purpose-built rentals and long-term care have had significant impacts for tenants, seniors, workers, and communities. It also points to actions that governments at all levels can take to curb financialization and mitigate its impacts.

This research and engagement will help the Federal Housing Advocate to develop legislative and policy recommendations for government to implement better protections against the financialization of housing and its impacts on people, disadvantaged groups, and communities. Measures to address financialization must put human rights first.

Other Business

Housing Pathways for Women and Gender Diverse People Working Group

This Working Group is a collaboration between community organizations from the Violence Against Women sector and City of Toronto staff.

In response to the Federal and Provincial budgets released this year, the group has written a letter to each order of government with comments and recommendations on how government funds can better be used to support the needs of women and gender diverse folks who are experiencing or at risk of homelessness.

They are asking for organizations to add their names to the letter in an endorsement of their recommendations.
