


Active COVID-19 outbreaks (shelters)

Recovery Program

- The Recovery Program has been very busy over the last several weeks as shelter outbreaks have increased
- Contingency plans to expand isolation / recovery space have been actioned
- Additional spaces secured that will double existing capacity
- SSHA is working with our health and community partners at the current recovery site to operationalize these new spaces over the coming week



Additional measures

- Additional funding provided for IPAC measures, wage enhancements, ventilation improvements
- Identification of IPAC lead/champion at each shelter
- Addressing testing fatigue e.g. through use of less invasive saliva based testing
- Pilot of rapid antigen testing as a screening tool
- Increasing supports and incentives for vaccination



Recently announced funding

- \$1 million will go to drop-ins to expand the availability of daytime indoor space
 - Funding will be made available through a call for proposals in collaboration with Toronto Drop-in Network
- \$2 million will go to shelters, 24-hour respites and drop-ins for the following:
 - IPAC support including the purchase of PPE to implement updates to the current directive (eye protection for staff and three-layer masks for clients), additional cleaning support, training etc.
 - Wage enhancements during outbreaks to ensure staffing levels are maintained
 - Activities to improve ventilation, such as higher quality HVAC filters or portable air filters
 - Activities to support vaccine roll out, including incentives for client participation



New Provincial IPAC requirements

- Emergency homeless shelters, including 24-hour respite sites, 24-hour women's drop-ins, temporary shelter facilities and hotels, are required to identify an individual in the organization to act as an IPAC lead
- The IPAC lead is required to complete <u>IPAC practices education</u> and training
- And are required to complete a self-audit in March 2021 using the <u>COVID-19 Preparedness and Prevention in Congregate</u> <u>Living Settings Checklist</u>



Ontario Ministry of Labour Focused Inspection Initiative

- On March 30, 2021 the Ministry of Labour will be expanding its provincewide inspections to emergency homeless shelters most at risk of COVID-19.
- Inspections will focus on shelters that are currently in an outbreak or have had an outbreak so as to ensure that they are properly protected from COVID-19, through measures such as:
 - Raising awareness of COVID-19 health and safety requirements; and
 - Increasing compliance with workplace health and safety laws.
- Service providers are encouraged to review the <u>Develop your COVID-19</u> workplace safety plan to ensure suitable recommended health and safety practices are in place.



Saliva Based PCR testing

- Effective but less invasive: PCR test so just as effective as swab test but less invasive
- Sites will be supported through process by Testing Partners
 - Webinar will be available to show how to instruct clients to provide sample
 - IPAC safe staff do not have to hold the container, but client deposits sample directly into tube
 - Testing team will drop off the kits and will arrange for pick-up
- Clients cannot drink/eat/smoke 30min prior to sample (currently being investigated)



Rapid Testing

- The Provincial Antigen Screening Program allows priority settings to add an additional safety measure in high-risk and essential workplaces to help reduce the spread of COVID-19
- Rapid antigen tests may proactively identify cases of COVID-19 that may have otherwise been missed
- The antigen test is used as a screening tool (i.e. not a diagnostic tool) and takes approximately 15 minutes for results
- SSHA is working with TPH to pilot rapid testing in shelter settings and based on learning will explore further roll-out



COVID-19 Vaccination Rollout for Clients

- Toronto's health care partners began vaccinating people experiencing homelessness starting the week of March 1, 2021, through clinics at shelters, day-time drop-ins and mobile clinics for people living outside.
- Ontario Health Teams have collectively immunized more than 1,200 clients at 54 clinics offered at City administered shelters and 24-hour respite sites
- Service providers are asked to continue to complete the <u>Vaccination Clinic Reporting survey</u> after every clinic
